Limitation on Liability: THE MAXIMUM LIABILITY, IF ANY, OF THE VILLAGE FOR ALL DAMAGES, INCLUDING WITHOUT LIMITATION CONTRACT DAMAGES AND DAMAGES FOR INJURIES TO PERSONS OR PROPERTY, WHETHER ARISING FROM VILLAGE'S BREACH OF THIS AGREEMENT, BREACH OF WARRANTY, NEGLIGENCE, STRICT LIABILITY, OR OTHER TORT, WITH RESPECT TO THE RENTAL OF THE SHELTER HOUSE, OR ANY SERVICES IN CONNECTION WITH THE SHELTER HOUSE, IS LIMITED TO AN AMOUNT NOT TO EXCEED THE RENTAL PRICE STATED HEREIN. IN NO EVENT WILL THE VILLAGE BE LIABLE TO RENTER FOR ANY INCIDENTAL, CONSEQUENTIAL, OR SPECIAL DAMAGES INCLUDING WITHOUT LIMITATION LOST REVENUES AND PROFITS, EVEN IF IT HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
- 10. <u>Severability:</u> If any term, provision, covenant or condition of this agreement is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remainder of the provisions will remain in full force and will in no way be affected, impaired or invalidated.
